The Board discussed the Liberty Township Bond Issuances that were being presented for approval. Mr. Newell and Mr. Rankey both described the projects and how the bonds were being structured. There were three bonds being submitted for approval for three projects: a Township Hall, a Maintenance Facility, and a Fire Station. Mr. Rankey confirmed that both the underwriting committee and the treasurer's office have approved the bonds.
