The 2700 acre rezoning had 600 acres of Light Industrial and 600 acres of Mixed-Use development within it. A main focus would be to reposition some of the 1990s product that exists today along the corridor.

Other Business

Mr. Lamb updated the Board on the Big Walnut MOU agreement that is being discussed. The MOU would discuss the targeted development meeting that staff would be planning and discuss with local elected officials about the benefits of development in their communities.

Staff requested that some funding be made available now so that the event planning for the end of the year event can be done quickly.
