# **Villages at Casement Bond Fund Application**

Jonathan Kabat and Andy Brossart presented a Bond Fund Application for a 395 acre residential mixed-use development in Lake County. This bond issuance of Phase one would be \$4.7mil for Delaware County and \$5.5mil for Warren County. The Painesville Township have agreed to TIF and additional NCA. The Developer requested the Delaware County Finance Authority (the "DCFA") to issue a total of approximately \$4,750,000 and the Warren County Port Authority (the "WCPA") to issue a total of approximately \$5,500,000 of tax-increment finance (TIF) and NCA backed bonds to fund a portion of the estimated \$22,265,000 of developer-financed public improvements.

#### **Mercedes Benz Bond Fund Application**

The applicant and Berkshire Township have agreed to TIF funding for improvements to US Route 36/State Route 37.

# **Legends Luncheon**

Mr. McDaniel gave an update on the Memorial Tournament Legends Luncheon, which raised \$1,450,000 for Nationwide Children's Hospital.

## **AAA Ohio Blue Jackets Update**

Mr. Gingher provided an update on the AAA Ohio Blue Jackets Facility slated for construction at the corner of US Route 42 and Sawmill Parkway on the west side of Delaware City. Mr. Gingher described a local ice shortage which will in part be solved with the addition of the new facility. The facility will include 3 rinks, with one being outdoor and canopied. The space will be utilized for outdoor concerts and events during the summer, showcasing the ability to use the facility year-round. 600,000 annual visitors are anticipated solely for Hockey related events. The development has been received positively by the public. It is expected that the development will catalyze the addition of hotels and other accommodations in the immediate area, boosting the economic vitality of the region.
