# Northport- Metro Development- Step Application

Jonathan Kabat and Joe Thomas presented a sales tax exemption application for Northport which will be a 154-suite residential hotel development. This project was previously approved by the Board in 2023, the incentive was revoked in July of 2024 due to the project not joining the Berlin Township JEDD. Northport began the process of annexation into Sunbury in June of 2024 and was finalized in October of 2024. Northport is now ineligible to join the Berlin Township JEDD. This project would generate money towards the TIF that is in place to help pay for infrastructure improvements and the construction of Sunbury Parkway.
